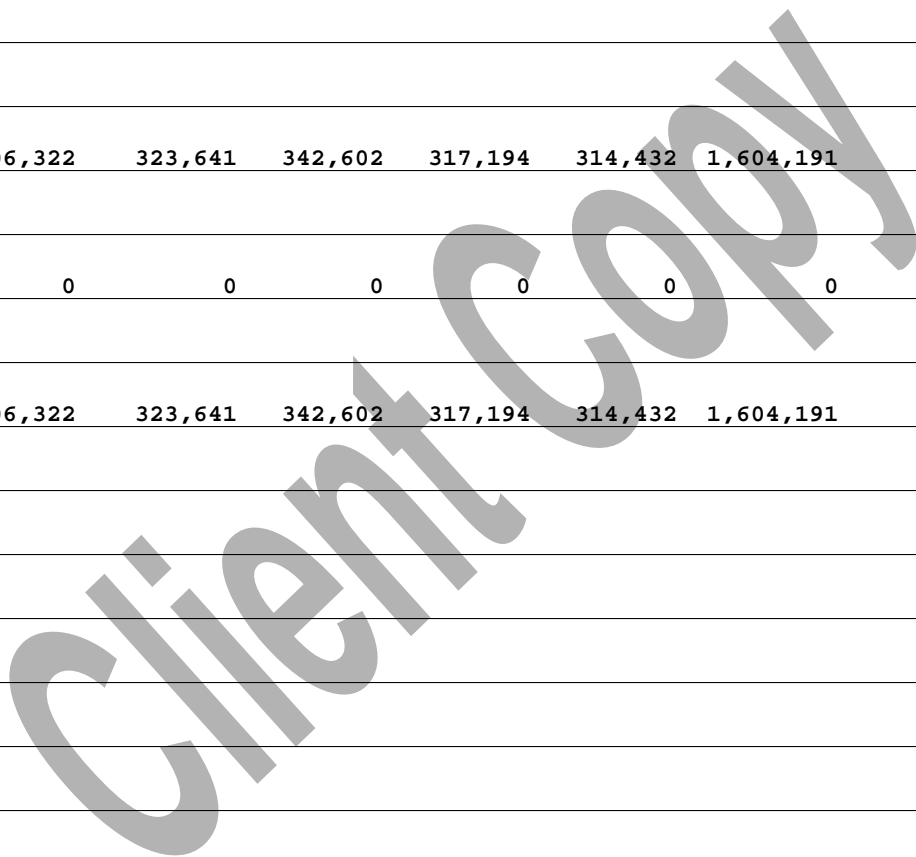

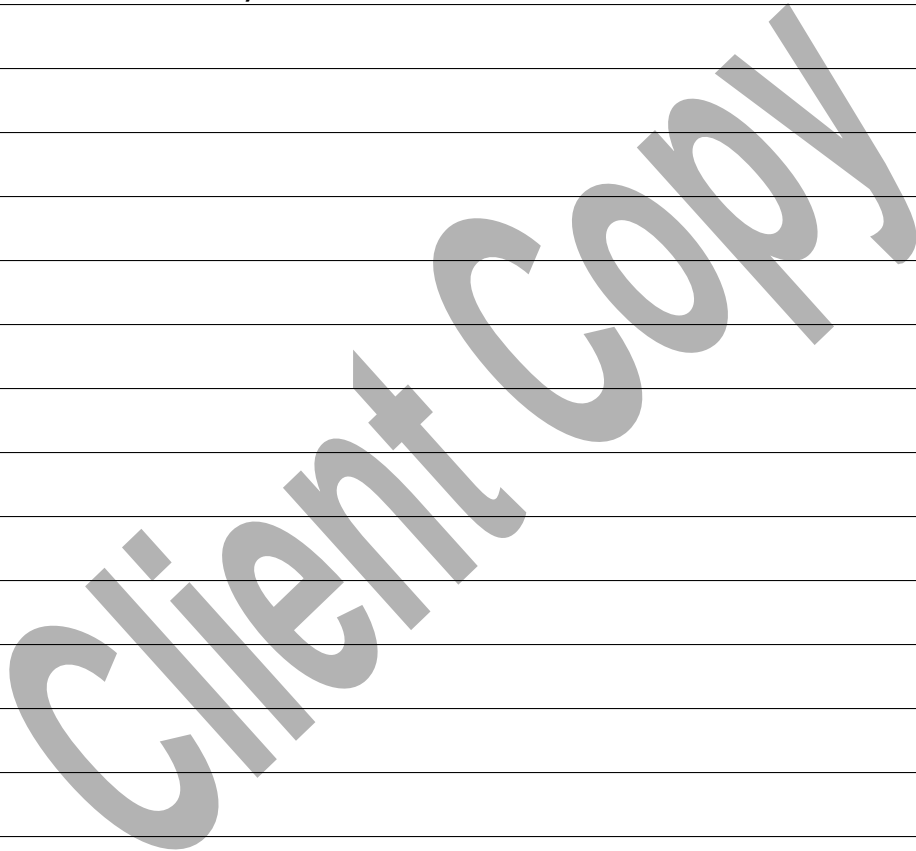

SINCE THE FOUNDATION WAS FOUNDED IN 1983, MORE THAN 4,877 CHILDREN HAVE BENEFITED FROM THE MAGIC OF A WISH. TOTAL PROGRAM SERVICE EXPENSES GRANTED FOR THE FISCAL YEAR WERE \$3,583,758.
